PUBLIC PARTICIPATION: Briefing & discussion on Somer Valley Enterprise Zone

Cllrs Hedges, Jeffery & Wade provided some history & context as well as information as to the current situation. There were a series of questions & concerns raised by local residents, with answers from Councillors where possible.

- # Will any road improvements include storm drains, to stop flooding? Answer: yes, this is a legal requirement.
- # Will all the bends on the A362 be improved? A; currently only at Sunnyside, but the Parish is still pushing for more.
- # There will be any entry roundabout onto the main road from the site.
- # Extra traffic at Sunnyside will make entry & exit from the terrace even more dangerous, even with improvements & will also increase pollution.
- # Nothing should be done until Sunnyside improvements have been agreed & completed.
- # The initial consultation had c.120 responses. There is another consultation in November, where previous comments will not be 'carried over' & so should be resubmitted.
- # Does B&NES have air pollution data ? A: Yes, but only collects certain chemical data at certain times.

The street lights that aren'y working. Clerk explained that there were problems with the contractors.
